

ORDINANCE NO. 893

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE FISCAL YEAR COMMENCING MAY 1, 2017, AND ENDING APRIL 30, 2018, OF THE VILLAGE OF TEUTOPOLIS, EFFINGHAM COUNTY, ILLINOIS.

WHEREAS, the Board of Trustees of the Village of Teutopolis, Effingham County, Illinois, did on July 19, 2017, pass Ordinance No. 884, the annual appropriation ordinance for said Village of Teutopolis for the fiscal year beginning May 1, 2017, and ending April 30, 2018, by which said ordinance there is appropriated the sum of \$7,803,400.00, plus the Sanitary Sewer Fund of \$1,614,600.00, and the Water Fund of \$1,916,900.00, for the various purposes therein specified; which said appropriation ordinance was read, passed and approved by the Village President on July 19, 2017; and, which said appropriation ordinance was duly published as provided by law and is now in full force and effect.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF TEUTOPOLIS, EFFINGHAM COUNTY, ILLINOIS:

Section 1: That there be and is hereby levied upon the taxable property within the corporate limits within the said Village of Teutopolis, Effingham County, Illinois, subject to taxation for the corporate purposes of said Village for the year beginning May 1, 2017, and ending April 30, 2018, the following sums for the following specified purposes mentioned in said appropriation bill, and in the respective sums as follows, for the total amount of appropriation being detailed under the column headed "Total Appropriation" and the total amount levied being detailed under the column headed "To Be Raised By Tax Levy", as follows:




TRUTH IN TAXATION
