

**ORDINANCE NO. 976**

**AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE FISCAL YEAR COMMENCING MAY 1, 2021, AND ENDING APRIL 30, 2022, OF THE VILLAGE OF TEUTOPOLIS, EFFINGHAM COUNTY, ILLINOIS.**

WHEREAS, the Board of Trustees of the Village of Teutopolis, Effingham County, Illinois, did on July 21, 2021, pass Ordinance No. 970, “AN ORDINANCE MAKING APPROPRIATIONS FOR THE CORPORATE PURPOSES OF THE VILLAGE OF TEUTOPOLIS, EFFINGHAM COUNTY, ILLINOIS, FOR THE FISCAL YEAR COMMENCING MAY 1, 2021, AND ENDING APRIL 30, 2022”, by which said Ordinance there was appropriated the sum of \$6,127,380.00, plus the Sanitary Sewer Fund of \$818,800.00, and the Water Fund of \$2,571,500.00, for the various purposes therein specified; which said appropriation ordinance was read, passed and approved by the Village President on July 21, 2021; and, which said appropriation ordinance was duly published and filed as provided by law, and is now in full force and effect.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF TEUTOPOLIS, EFFINGHAM COUNTY, ILLINOIS;

Section 1: That there be and is hereby levied upon the taxable property within the corporate limits within the said Village of Teutopolis, Effingham County, Illinois, subject to taxation for the corporate purposes of said Village for the year beginning May 1, 2021, and ending April 30, 2022, the following sums for the following specified purposes mentioned in said appropriation bill, and in the respective sums as follows, for the total amount of appropriation being detailed under the column headed “Total Appropriation” and the total amount levied being detailed under the column headed “To Be Raised By Tax Levy”, as follows:

Section 2: Certification: That the Village Clerk shall certify that the Village has complied with the requirements of the Truth in Taxation Act (35 ILCS 200/16-55 et. Seq.) in adopting this tax levy.

Section 3: Filing: That the Village Clerk shall make and file with the County Clerk of the County of Effingham a duly certified copy of this Ordinance and that the amount levied by Section 1 of this Ordinance is required by said Village of Teutopolis as aforesaid and extended upon the appropriate tax books for the fiscal year of said Village of Teutopolis beginning May 1, 2021 and ending April 30, 2022.

Section 4: If any section, subdivision, sentence or clause of this Ordinance is for any reason held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance.

Section 5: This Ordinance shall be in full force and effect ten (10) days from and after its passage and approval and may be viewed in the Village Clerk's office as provided by law.

Section 6: If there is an error in printing, the publishing requirement of this act shall be accomplished by reprinting that portion of the Ordinance which was in error as above enumerated within 30 days after passage is validated.





**TRUTH IN TAXATION  
CERTIFICATE OF COMPLIANCE**

I, the undersigned, hereby certify that I am the Village President and the presiding officer of the Village of Teutopolis, and as such Village President and presiding officer, I certify that the Tax Levy Ordinance, a copy of which is attached, was adopted pursuant to, and in all respect in compliance with, the provisions of Section 18-60 through 18-85 of the "Truth in Taxation Act".


Check one of the Choices Below:

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the "Truth in Taxation Law."
- 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- 3) The *proposed* aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore a hearing was not held. The *adopted* aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the "Truth in Taxation Law."
- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the "Truth in Taxation Law."

This certificate applies to the fiscal year commencing May 1, 2021 and ending April 30, 2022.
