

**REGULAR BOARD MEETING
VILLAGE OF TEUTOPOLIS
OCTOBER 19, 2022**

The regular meeting of the President and Board of Trustees of the Village of Teutopolis, Effingham County, State of Illinois, was held in the Village Hall of said Village, October 19, 2022, at 7:00 p.m.

The President called the meeting to order and upon roll call the following trustees were present:

A hearing was held to review the delinquent water bills. None of the persons having a delinquent bill were present at the hearing. Since no one was present to give just cause for being late the Village Foreman was instructed to disconnect their water on the 20th.

It was moved by Angela Kroeger, seconded by Daniel Zerrusen and carried that the minutes of the last meeting be approved as presented.

It was moved by Greg Oseland, seconded by Daniel Zerrusen and carried that the treasurer's report be accepted and place on file.

It was moved by Daniel Zerrusen, seconded by Angela Kroeger and carried that the board report be approved, and the October bills paid.

Aaron Niebrugge from W.E.T. Pools and Spas was present to address the board on the safety of walkable pool covers. He gave each board member information on these types of covers. The of covers usually last anywhere from 7 to 10 years before they have to be replaced. The board thanked him for the information, and they will discuss further at a future board meeting.

Motion by Daniel Zerrusen, seconded by Jane Summers to approve the purchase of 6 Chromebooks and 6 Chromebook cases from Magoo & Associates in the amount of \$2,165.52. Roll call vote – 5 yes, 0 nays, 1 absent, motion carried.

Motion by Greg Oseland, seconded by Daniel Zerrusen to pass Resolution No. 652, A Resolution to Abate Tax Levy for the Year 2022. Roll call vote – 5 yes, 0 nays, 1 absent, motion carried.

Daniel Zerrusen introduced Ordinance No. 997, An Ordinance for the Levy and Assessment of Taxes for the Fiscal Year Commencing May 01, 2022 and Ending April 30, 2023, of the Village of Teutopolis, Effingham County, Illinois. Greg Oseland made a motion to pass with the revision of changing the date to read April 30, 2023, seconded by Jane Summers to pass Ordinance No. 997. Roll call vote – 5 yes, 0 nays, 1 absent, motion carried.


The discussion on IMRF with an IMRF representative was tabled and will be discussed at a future meeting.
