

**REGULAR BOARD MEETING
VILLAGE OF TEUTOPOLIS
DECEMBER 21, 2022**

The regular meeting of the President and Board of Trustees of the Village of Teutopolis, Effingham County, State of Illinois, was held in the Village Hall of said Village, December 21, 2022 at 7:00 p.m.

The President called the meeting to order and upon roll call the following trustees were present:

A hearing was held to review the delinquent water bills. None of the persons having a delinquent bill were present at the hearing. Since no one was present to give just cause for being late the Village Foreman was instructed to disconnect their water on the 22nd.

It was moved by Greg Oseland, seconded by Jane Summers and carried that the minutes of the last meeting be approved as presented.

It was moved by Greg Oseland, seconded by Daniel Zerrusen and carried that the treasurer's report be accepted and place on file.

It was moved by Greg Oseland, seconded by Jane Summers and carried that the board report be approved, and the December bills paid.

Carl Pals informed the board that the Illinois EPA conducted a sewer plant inspection. A few minor deficiencies were found. The main concern of the inspector was to put a chlorine detector at the sewer plant. The board approved Carl to purchase a chlorine detector. Carl will have to write a letter to the Illinois EPA within the next 45 days informing them the deficiencies were corrected.

Clay Zerrusen was present to inquire about when the agreement for Jim and Lois Meinhart would be ready for them to review. The board advised they would contact our attorney and see when it would be ready for review.

Lee Beckman with Milano & Grunloh was present to give a quick update on the status of the grants the Village has applied for. He said it would probably be early 2023 before we find anything out.

The board gave President Repking approval to sign an agreement with Zenner Meter Company in the amount of \$3,606.70. This agreement gives software support for the Village's Zenner radio read water meters.

Greg Oseland introduced Ordinance No. 999, An ordinance Amending Chapter 71 of the Code of Ordinances for the Village of Teutopolis, Illinois (Golf Cart and Recreational Off-Highway Vehicles). Motion by Daniel Zerrusen, seconded by Jane Summers to pass Ordinance No. 999. Roll Call vote 3 yes, 0 nays, 3 absent, motion carried.

President Repking informed the board IDOT finished their speed study, and the speed limit will be lowed to 40 mph along Route 40 starting at Performance Lawn and Power.


The board approved the \$1,000 bond to be paid back to Adam & Amy Goeckner (Lot 30) in Prairie View Subdivision.

In other action the board tabled items (a) and (b) until the first meeting in January 2023.

It was moved by Greg Oseland, seconded by Daniel Zerrusen and carried to adjourn the meeting.
