REGULAR BOARD MEETING VILLAGE OF TEUTOPOLIS JUNE 18, 2025

The regular meeting of the President and Board of Trustees of the Village of Teutopolis, Effingham County, State of Illinois, was held in the Village Hall of said Village, June 18, 2025, at 7:00 p.m.

The President called the meeting to order, and upon roll call, the following trustees were present:

A hearing was held to review the delinquent water bills. None of the persons having a delinquent bill were present at the hearing. Since no one was present to give just cause for being late, the Village Foreman was instructed to disconnect their water on the 19th.

It was moved by Bernard Hartke, seconded by Greg Oseland, and carried that the minutes of the last meeting be approved as presented.

It was moved by Greg Oseland, seconded by Bernard Hartke, and carried that the board report be approved and the June bills paid.

Mitch Hardiek from Milano & Grunloh attended the meeting to discuss several topics, including MFT road oiling and an update on grant applications. He also mentioned ongoing discussions about the Safe Routes to School (SRTS) sidewalk project and the crossing at the railroad.

Regarding Oak Street, the drainage has been completed. However, the subsoil base near the parking lot was found to be in poor condition, necessitating the addition of 16 inches of rock to address the issue.

Unfortunately, the Cast Iron Replacement project was unsuccessful in securing funding from the Durbin and Bost grant this year.

Item (a) Discussion and possible action on the annual MFT road oiling is tabled until the July 2nd meeting.

Motion by Greg Oseland, seconded by Robin Imburgia, to approve the Sloan Implement quote of \$14,499 to purchase a John Deere X750 lawn mower. Roll call vote – 4 yes, 0 nays, 2 absent, motion carried.

Item (c) Discussion on amending the Golf Cart and Recreational Off-Highway Vehicle Ordinance was tabled.

Sasha Althoff will be at the July 2nd meeting to discuss expanding the Effingham Enterprise Zone to include Ruholl Trailer Sales' new building.

Following the discussion, the board decided to postpone further deliberation on the implementation of a Village of Teutopolis Handbook until they have time to review a sample copy.

The board discussed Garage Band Night. Greg Oseland said the next Teutopolis for Tomorrow meeting is July 14th. President Repking plans to attend that meeting to discuss unlicensed golf carts and off-highway vehicles.

The board will proceed with the IRWA Apprenticeship Program if no qualified applicants are received. IRWA will charge \$1,200 per student for obtaining a Class 4 Wastewater License and a Class B Water License.

Item (h) Discussion on metal carports was tabled.
