

**REGULAR BOARD MEETING
VILLAGE OF TEUTOPOLIS
AUGUST 20, 2025**

The regular meeting of the President and Board of Trustees of the Village of Teutopolis, Effingham County, State of Illinois, was held in the Village Hall of said Village, August 20, 2025, at 7:00 p.m.

Village Engineer Mitch Hardiek conducted the 2025 MFT bid opening. He also gave the board updates on the Prairie View Subdivision Phase 2 Sidewalk Project.

The Board received a bid from Larry Heurman Trucking for the 2025 MFT Road Oiling Project.

Motion by Daniel Zerrusen, seconded by Bernard Hartke, to approve the 2025 MFT Road Oiling Project to Larry Heurman Trucking for \$90,502.50. Roll call vote – 6 yes, 0 nays, motion carried.

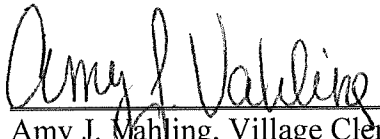
Item (d) Review and approve the electronic sign bid was tabled until a future meeting.

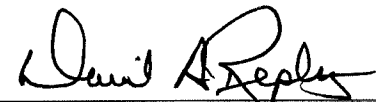
